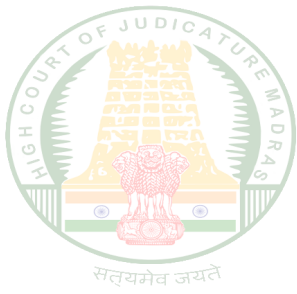

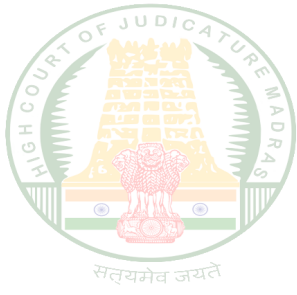
2.Considering the reasons assigned in affidavit filed in support of this petition, we are inclined to allow this petition.
