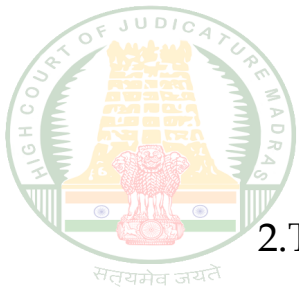

Writ Petition filed under Article 226 of the Constitution of India, praying for the issuance of Writ of Certiorarified mandamus calling for the records relating to the impugned order of suspension purported to have been issued by the 2nd respondent in Rc.No. 1308/2023 dated 25.01.2023, quash the same and consequently direct the respondents herein to regularize the period of suspension of the petitioner with all monetary and service benefits.

ORDER

The petitioner has made serious allegations that she has been sexually harassed by the Secretary/Correspondent of the School. The petitioner has lodged a complaint and therefore, he has also been removed from the post and the School is now under the administration of Waqf/5th respondent.
