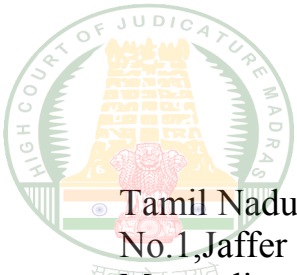

Prayer:S-2(Suspension order)Writ Petition, filed under Article 226 of the Constitution of India, praying this Court to issue a Writ of Certiorarified mandamus calling for the records relating to the impugned order of suspension purported to have been issued by the 2nd respondent in Rc.No. 1308/2023 dated 25.01.2023, quash the same and consequently direct the respondents herein to regularize the period of suspension of the petitioner with all monetary and service benefits and pass such further or other orders as this Honble Court may deem fit and proper in the circumstances of the case and thus render justice.

ORDER

This writ petition has been filed aggrieved by the order passed the respondents 2 & 3 placing the petitioner under suspension vide proceedings dated 25.01.2023. However, admittedly no subsistence allowance has been paid for the past more than three years nor the petitioner is reinstated into service, nor any disciplinary proceedings have been initiated against the petitioner as on date. There appears to be some dispute with regard to the management of the school in question.

2. Be that as it may, it is the primary obligation on the part of the management to pay subsistence allowance once an employee is placed under suspension. The absence of payment of such allowance would amount to a violation of the right to life guaranteed under Article 21 of the Constitution of India.

3. In the circumstances, the respondent No.3 is directed to pay all the arrears of subsistence allowance due as on date, within a period of six weeks from the date of receipt of a copy of this order. If the subsistence allowance is not paid within the time stipulated above, this court will be constrained to quash the impugned proceeding, without going into the merits of the matter.

4. Post the matter after six weeks under the same caption.
