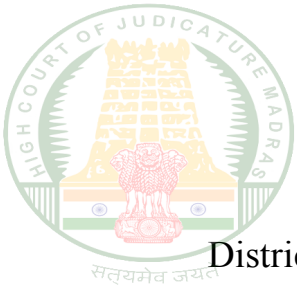

ORDER

The petitioner is before this Court seeking issuance of a Writ of Mandamus directing the second respondent to grant permission to run a plastic grinding unit in the property bearing Survey No.78/12, Muthumothanmozhi Village, Radhapuram Panchayat Union, Tirunelveli District.

2. The petitioner had earlier approached this Court in W.P.(MD) No.6024 of 2025, and this Court, by order dated 07.03.2025, disposed of the said Writ Petition granting liberty to the petitioner to submit a fresh application before the first respondent. Pursuant thereto, the petitioner attempted to submit an online application. However, according to the petitioner, due to technical glitches, the application could not be successfully uploaded.

3. Mr. S.S. Madhavan, learned Additional Government Pleader, who accepts notice on behalf of the first respondent, submitted that similar applications have been successfully submitted through the E-Seva Kendra, and therefore the petitioner may also approach the E-Seva Kendra for uploading the online application.

4. In view of the above, this Writ Petition is disposed of, granting liberty to the petitioner to submit a fresh online application with the assistance of the E-Seva Kendra. If such an application is submitted, the respondents shall consider the same on its own merits and in accordance with law within a period of four (4) weeks from the date of receipt of the application. The petitioner shall submit the online application within a period of four (4) weeks from today. No costs.
