ORDER

This writ petition has been filed seeking a writ of mandamus directing respondents 1 to 6 to give due share to the petitioner and her son Chandrasekar / seventh respondent in the terminal benefits that are due and payable to the eighth respondent consequent upon his superannuation from service.

2. The case of the petitioner is that the eighth respondent, who is her son, was provided with compassionate appointment with her consent and the consent of her other son, who is the seventh respondent herein. It is the further case of the petitioner that the eighth respondent has totally neglected her right from the time he secured appointment under compassionate grounds and has not taken care of her and it is only the seventh respondent, who is taking care of the petitioner. In such circumstances, the petitioner claims to have submitted a representation dated 12.02.2026 to the first respondent to

give due share from and out of the terminal benefits payable to the eighth respondent, who is due for retirement by the end of this month. Complaining inaction on the part of the first respondent on her representation, the petitioner has approached this Court by filing this writ petition.

3. This Court, having taken note of the facts and circumstances of the case, is thoroughly convinced that a writ petition with the relief as sought for in this writ petition cannot be entertained under Article 226 of the Constitution of India. In such circumstances, this writ petition is dismissed as not maintainable. However, it is made clear that it is open to the petitioner to take appropriate steps to pursue her claim in accordance with law. No costs.
