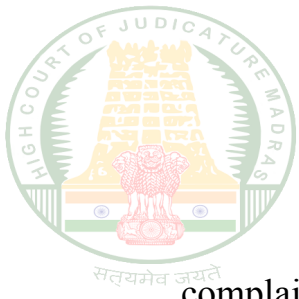
ORDER

The present Writ Petition is filed for a Writ of Mandamus directing the respondent no.2 to effect patta in the name of the petitioner for the agricultural lands in S.No.418/2B1, 418/4A, V.Muthulingapuram, Virudhunagar Taluk, Virudhunagar District based on the Transfer of Patta Online application in No.2026/0103/26/007552, dated 28.02.2026 and her representation dated 28.02.2026.

2. Mr.D.Gandhiraj, learned Special Government Pleader takes notice for R1 and R2. Since no adverse orders are going to be passed as against the respondents 3 and 4, notice to them is dispensed with.

3. By consent, this Writ Petition is taken up for final disposal at the admission stage itself.

4. According to the petitioner, her husband was in possession of the disputed property through oral partition effected in the petitioner's family. However, the respondents 3 and 4 have included the petitioner's property along with other properties and obtained a patta. The petitioner has preferred a complaint before the concerned Police Station. The petitioner has also filed Crl.O.P.(MD)No.4795 of 2026 before this Court to register the

complaint, which was disposed of directing the concerned Police officials to consider the petitioner's complaint. In such circumstances, the petitioner has come with the present petition seeking to issue patta in her name.

5. Heard both sides.

6. In view of the facts and circumstances of the case, this Court directs the Tahsildhar, Virudhunagar Taluk / second respondent to issue notice to the petitioner as well as the respondents 3 and 4, conduct enquiry in this regard and thereafter, pass orders in accordance with law. The said exercise shall be completed within a period of three (3) months from the date of receipt of a copy of this order.

7. With the above directions, this Writ Petition is disposed of. No costs.
