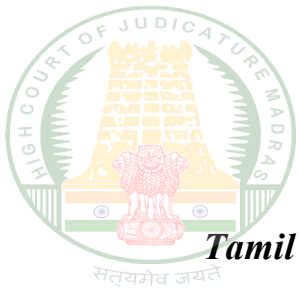
ORDER

The learned counsel on either side unanimously agree that the issue involved in this Writ Petition is squarely covered by the various judgments passed by the Division Bench of this Court in W.A.(MD) No. 403 of 2010 and batch, dated 18.03.2014 [*The Managing Director, Tamil Nadu State Transport Corporation (Madurai) Limited, Bye-Pass Road, Madurai and another vs. A. Thambi Raj and others*] and in W.A.(MD) No.1419 of 2021 and batch, dated 26.07.2021 [*A. Tamilarasan vs. The*

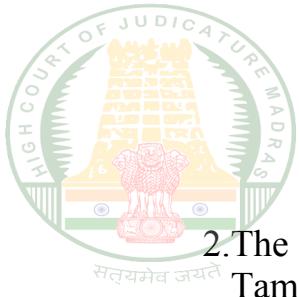
