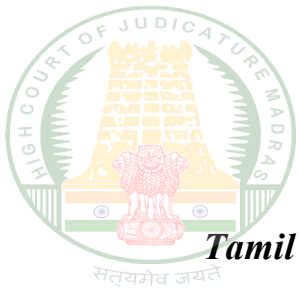
ORDER

The respondents are further directed to comply with the said direction as expeditiously as possible, at any rate, within a period of twelve weeks from the date of receipt of a copy of this order. No costs.
