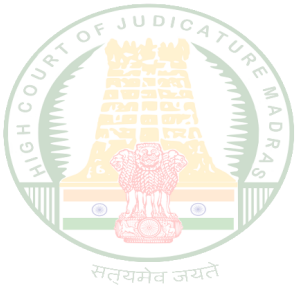

26.03.2026. Private notice is also permitted.

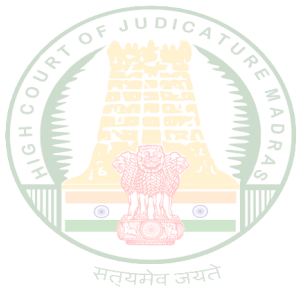
