ORDER

The present writ miscellaneous petition has been filed seeking to modify the order dated 26.09.2022 made in W.P(MD)No.1918 of 2013 wherein this Court has directed the respondent authorities to disburse a sum of Rs.1,34,25,705/-.

2. According to the learned Additional Solicitor General of India appearing for the TWAD Board, based upon some erroneous calculation, the above said amount was arrived at by the officials concerned. However, on verification, it has been found that the writ petitioner would be entitled to only a sum of Rs.33,50,862/-.

3. For considering the modified application, the respondent is directed to disburse a sum of Rs.33,00,000/- (Rupees Thirty Three Lakhs only) on or before **10.01.2026** to the writ petitioner.

4. Post the matter **12.01.2026**, for reporting compliance.
