Prayer: Writ Petition filed under Article 226 of the Constitution of India, praying this Court to issue a Writ of Certiorarified Mandamus call for the records pertaining to the impugned order passed by the 1st respondent in Na.Ka.2678216/2024/U(2) dated 26.06.2025 and quash the same and consequently direct the respondent 1 and 2 to cancel patta pertaining to SF No.166/2B3A, 166/2B3B, 166/2B3C and 166/2B3D stood in the name of respondents 3 to 8 and consequently direct the respondents 1 and 2 to issue patta in favour of the petitioner pertaining to S.F.No.166/2B of Thirushotruthurai Village, Thiruvaiyaru Taluk, Thanjavur District on the basis of his settlement deed dated 12.05.1993 in document No.399 of 1993.

ORDER

The petitioner claims rights over the property based on the registered settlement deed and other sale deeds. According to the petitioner, respondents 3 to 8 do not possess any title documents except revenue records, such as the natham patta.

2. Therefore, there shall be an order of interim stay. The petitioner, as well as respondents 3 to 8 and any other claimants, shall not disturb or encumber the property until the disposal of this writ petition.

3. Mr.SRA.Ramachandran, the Additional Government Pleader, takes notice for R-1 & R-2. Notice to R-3 to R-8. Private notice is also permitted.
