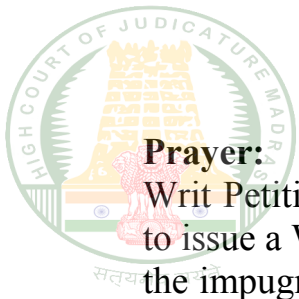

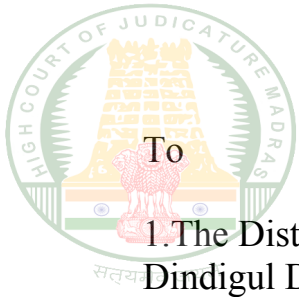
ORDER
