Prayer in W.P.(MD) No.7239 of 2026 : Writ Petition filed under Article 226 of the Constitution of India for issuance of a Writ of Certiorarified Mandamus, calling for the records relating to the impugned order O.Mu. No.E2/371/2026 dated 06.03.2026 passed by the 4th respondent and quash the same, and further direct the respondents 1 to 4 to refrain themselves from conducting survey and fixing boundaries in respect of Lands in S. Nos.193/4B, 160/1, 136/1A, 35/20B, 41/10B, 41/10A1, 136/1B, 100/1B, 41/10A, 133/5A, 133/6A and 133/7 in Kallanai Village, Alanganallur, Madurai District until disposal of the Statutory Appeal pending on the file of the 1st respondent / Land Commissioner, Chennai on the basis of the appeal submitted the petitioners dated 16.02.2026.
