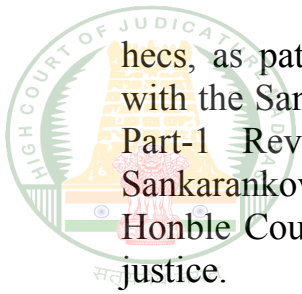

ORDER

The contention of the petitioner is that T.S.No.21 is pathway which extends extends up to the petitioner's land situated in T.S. No. 27. However in between small a portion in T.S.No.26/2, a person has encroached the land and constructed a house, for which he relies on Document No.1530/2014. In the said document, the four boundaries state that on the southern side there is an east-west road, which is not the northern boundary.

2. Therefore, the third respondent shall issue notice to the petitioner as well as to the fifth respondent and conduct a survey based on the above said document and also refer to other available records. After conducting the survey, the third respondent shall submit a report before this Court on or before 27.04.2026.

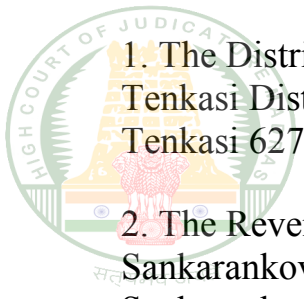
3. Issue notice to the fifth respondent, returnable by 27.04.2026. Private notice is also permitted.
