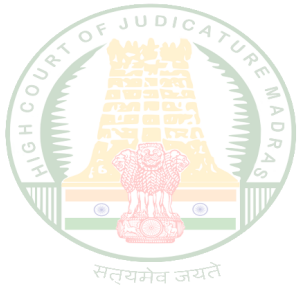

PRAYER : Petition filed under Article 226 of the Constitution of India, to issue a Writ of Certiorarified Mandamus, to call for the records pertaining to the Impugned Order of Transfer issued by the Respondent No.1 in Na.Ka.No.1955/2025/Po.Ni. 1 dated 28.02.2026 and consequential impugned order passed by the 2nd Respondent in Na.Ka. No.336/2026/C1 dated 03.03.2026 and quash the same as illegal in respect of the petitioner is concerned and consequently direct the Respondent No.1 to permit the Petitioner to continue as Sanitary Officer at Thirumangalam Municipality or, in the alternative, consider the Petitioner's representation dated 14.03.2026 for posting at Dindigul, or Madurai Corporation.
