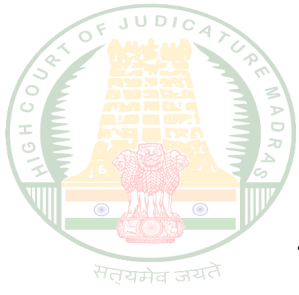

4. In view of the above, status quo as on date, with reference to the status of the petitioner, shall be maintained till 23.03.2026.

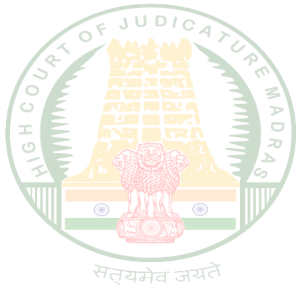
