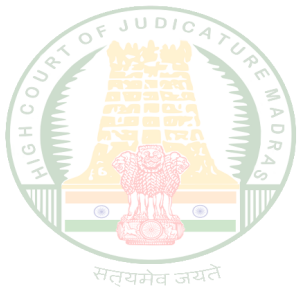

ORDER

This Civil Revision Petition seeks a direction to the learned Subordinate Judge at Srivilliputhur to dispose of EP No.138 of 2018 in LAOP No.5 of 1995 expeditiously.

2.Pursuant to the directions given by this Court on 09.06.2026, Mr.Suriya Prakash representing Mr.S.I.Muthiah has produced a letter from the Assistant Collector In-charge, Sivakasi to the effect that the admitted sum of Rs.13,70,438/- has been deposited to the credit of EP.No.138 of 2018 in LAOP.No.5 of 1995 on 23.06.2026. The decree holder/civil revision petitioner is entitled to this amount, as there is no dispute between the parties on this figure. The decree holder can file an application for withdrawal of the amount deposited on 23.06.2026. On filing a payment out application, the Executing Court shall order the payment out. The judgment debtor shall endorse no objection, as the amount, as stated above, is undisputed.

3.Insofar as the revision is concerned, it seeks for expeditious disposal of E.P.No.138 of 2018. There is a difference in the amount claimed in the execution petition and the amount which the judgment debtor says he is liable to pay.

4.The decree holder has already filed his memo of calculation before the Executing Court. Mr.Suriya Prakash states that the calculation memo

will be filed within a period of three weeks from the date of uploading a copy of this order to the official web-site of this Court. The Executing Court shall dispose of E.P.No.138 of 2018 in LAOP.No.5 of 1995 within a period of three months from the date of the calculation memo being filed by the judgment debtor. No petition for extension of time for filing the calculation memo will be entertained at the instance of the judgment debtor. The Executing Court is requested not to address any letters seeking extension of time.

5.The Civil Revision Petition stands disposed of. No costs.

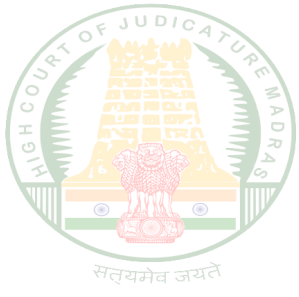
