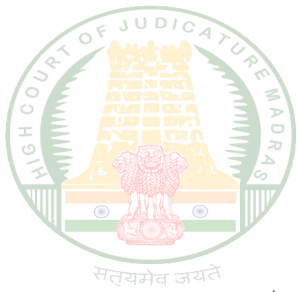

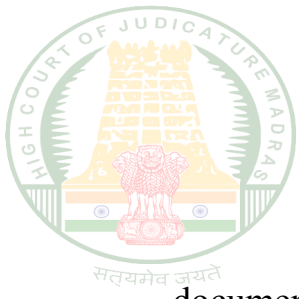

ORDER
