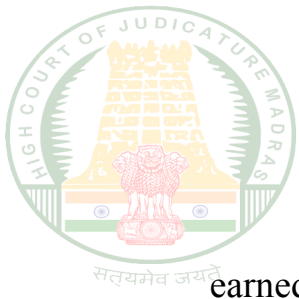

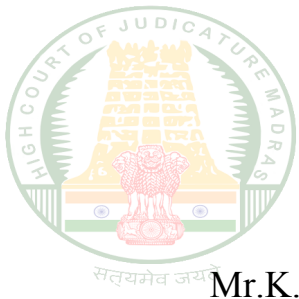

ORDER

This writ petition has been filed seeking Writ of Mandamus directing the respondents to revise the pay of the petitioner with effect from 01.01.2016 notionally and to pay difference in gratuity, difference in earned leave salary with effect from the date of retirement of the petitioner together with interest at the rate of 18% per annum in terms of 7th Pay Commission Recommendations for revision of pay scales as per G.O.Ms.No.134, Transport (D) Department dated 09.04.2018.

2. This matter earlier came up for consideration before this Court on 30.03.2026 and the same was adjourned to enable



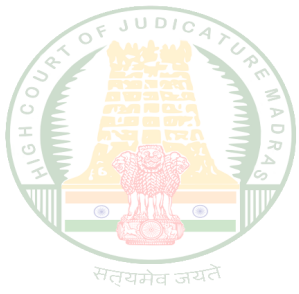

Mr.K.Ramaiah, learned Standing Counsel to get instructions in the matter.

3. Today, when the matter is taken up for consideration, Mr.K.Ramaiah, learned Standing Counsel appearing for the respondents submitted that the petitioner is entitled for all the benefits under 7th Pay Commission recommendations in the light of orders issued in G.O. (Ms)No.134 Transport (D) Department, dated 09.04.2018.

4. The grievance of the petitioner in the present writ petition is though the pay and pension of the petitioner has been revised in terms of the 7th Pay Commission recommendations, consequent upon the G.O. (Ms)No.134, dated 09.04.2018, the differential amount of gratuity and earned leave salary has not been paid. Hence, the petitioner claimed to have submitted a representation, dated 23.07.2024 before the respondent Corporation. But the respondents have not taken any action so far. Hence, the petitioner approached this Court by filling the present writ petition.

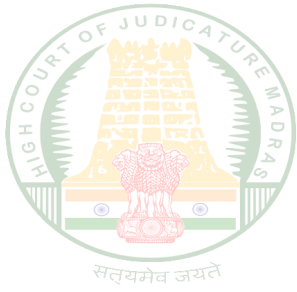

5. In the light of the admitted fact that the petitioner is entitled for 7th Pay Commission recommendations and the revised pay scales in terms of G.O.(Ms)No.134, dated 09.04.2018, the entitlement of the petitioner for differential amount of gratuity and earned leave salary, on revision of his pay scale in terms of 7th Pay Commission recommendations cannot be denied.

6. As the issue is still pending for consideration before the respondents, the second respondent is directed to consider the representation dated 23.07.2024 submitted by the petitioner, duly taking into consideration the orders issued in G.O.(Ms)No.134 dated 09.04.2018 and the observation made herein and pass appropriate orders and release the differential amount for which the petitioner is entitled to, along with 6% interest per annum, as expeditiously as possible, at any rate within a period of eight (8) weeks from the date of receipt of a copy of this order.
