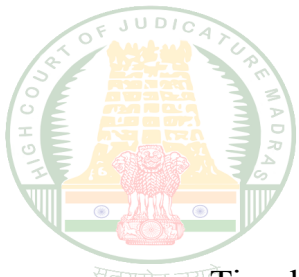

ORDER

The decree holder in O.S.No.76 of 2019 on the file of IV Additional Subordinate Court, Tiruchirappalli, has filed the present Civil Revision Petition seeking expeditious disposal of her final decree application.

2. A perusal of the records reveal that the plaintiff is the decree holder in a suit for dissolution of partnership firm and for rendition of accounts. The plaintiff has filed I.A.No.10 of 2024 for passing of final decree. The Court has appointed a senior member of the Bar, as Advocate Commissioner on 18.12.2024 to submit a report. According to the learned counsel appearing for the petitioner, the first defendant is not cooperating with the Advocate Commissioner for rendition of accounts. Hence, the present Civil Revision Petition has been filed.
