Prima facie, the impugned order passed by the Principal District Munsif Court, vide order dated 09.02.2023 in I.A.No.1 of 2022 in O.S.No.1111 of 2015 rejecting the application for amendment of the plaint and the relief is incorrect and liable to be interfered with. Therefore, there shall be an order of interim stay of all further proceedings in O.S.No.1111 of 2015 before Principal District Munsif Court, Trichy for a period of five weeks.
