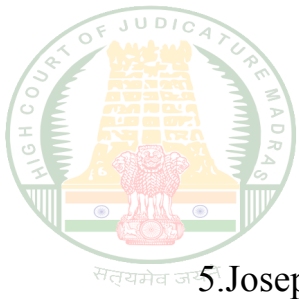

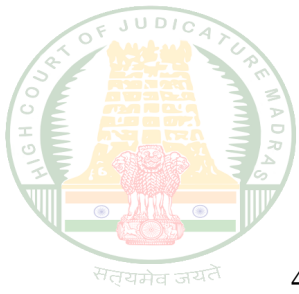
COMMON ORDER
