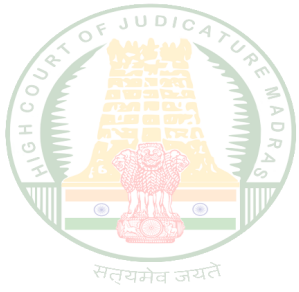

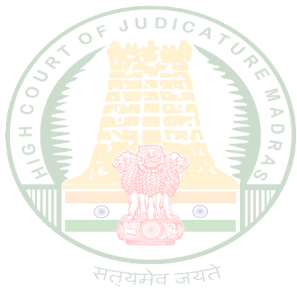

6. List the matter during third week of June, 2026.

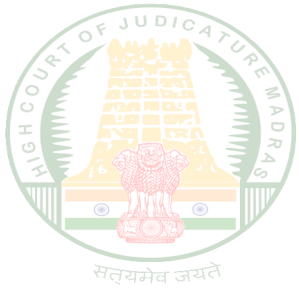

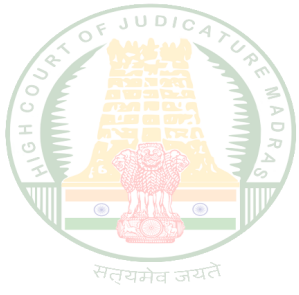
