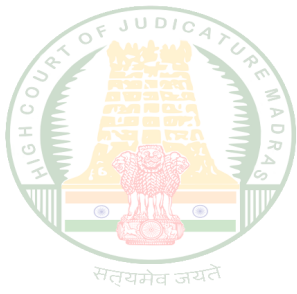

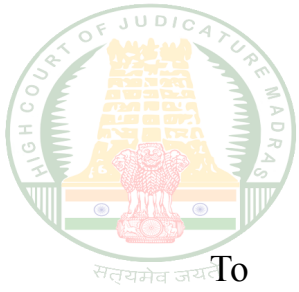
Mr.S.P.Maharajan, learned Special Government Pleader,

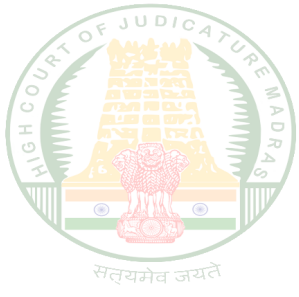
