Considering that an effective alternative remedy is available under Section 10 of the Land Encroachment Act, liberty is granted to the petitioner to file an appeal before the concerned authorities, within a period of two weeks from the date of receipt of a copy of this order. Till such time, no coercive steps shall be taken by the respondents against the petitioner.

4. In view of the above, this writ petition is dismissed. No costs. Consequently, connected miscellaneous petitions are closed.
