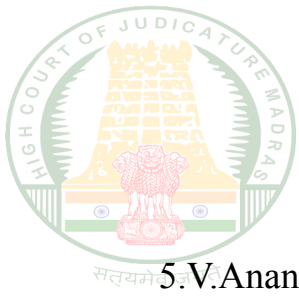

Prayer in W.P(MD)No.13960 of 2026: Writ Petition is filed under Article 226 of the Constitution of India, praying this Court to issue a Writ of Certiorarified Mandamus, to call for the records of the impugned order in Ref No.TP : HR : IR: INTUC, issued by the second respondent, the Assistant General Manager & Head (HR) BHEL Trichy, dated 27.12.2025 and quash the same, insofar as it directs the petitioner to obtain an order from a competent Court of Law on the question of the rightful holder of the post of the General Secretary and further direct the respondents, their men, agents, servants or any one claiming under them, to forbear from interfering with or in any manner disrupting the petitioner from the performance of his duties and responsibilities as the duly elected General Secretary of BPEU-INTUC.

Prayer in W.M.P(MD)No.10406 of 2026: To grant an order of interim stay of the operation of the impugned order in Ref No: TP : HR : IR : INTUC issued by the second respondent, the Assistant General Manager & Head (HR) BHEL Trichy, dated 27.12.2025 and quash the same, insofar as it directs the petitioner to obtain an order from a competent Court of Law on the question of the rightful holder of the post of the General Secretary pending disposal of the writ petition.
