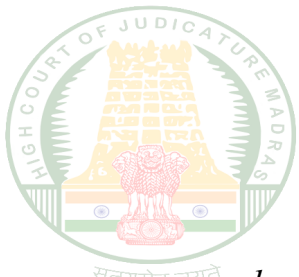

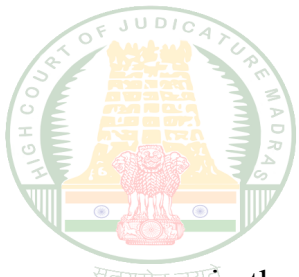

ORDER

The present writ petition has been filed seeking a direction forbearing the respondents from erecting an electrical pole in the petitioner's land comprised in Survey No.31/2A-1, situated at Viruchampatti Majra, Vilathikulam Taluk, Tuticorin District, by considering the representation of the petitioner dated 10.05.2019.

2. This Court, by order dated 05.02.2026, directed the authorities to conduct a survey and ascertain whether any electrical pole had been erected
