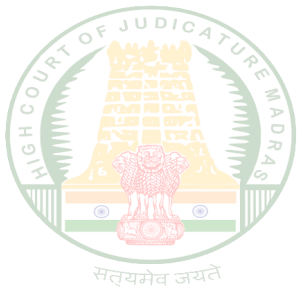

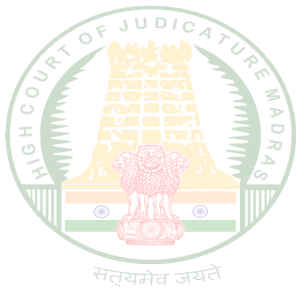
ORDER

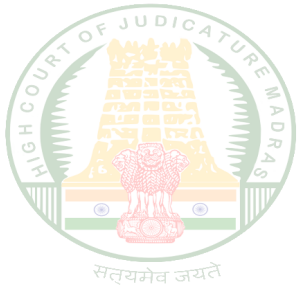
