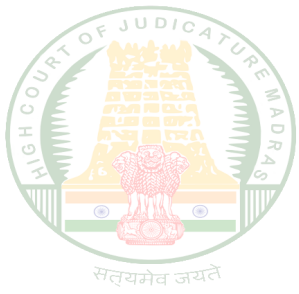

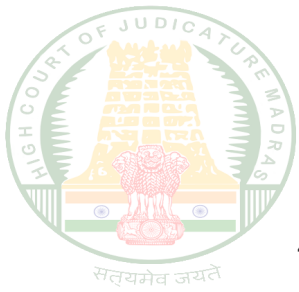

ORDER

This Writ Petition has been filed seeking the issuance of a Writ of Mandamus directing the respondents to grant prior permission to fill up the post of B.T. Assistant (English) by considering the proposal submitted by the petitioner dated 30.04.2025.

2. The case of the petitioner is that the post of B.T. Assistant (English) fell vacant in the petitioner school on 01.09.2022. The petitioner has been seeking prior permission to fill up the said vacancy. But, the same has not been granted. Finally, the petitioner school claims to have finally submitted a proposal on 30.04.2025 seeking permission from the first respondent to fill up the vacant post and no orders have been passed on the said request as on date.

3. Mr.N.Satheesh Kumar, learned Additional Government Pleader appearing for the respondents, on instructions, submits that the said proposal dated 30.04.2025 is still pending consideration before the first respondent.

In the light of the above, this Court is of the considered view that it is not open for the first respondent to sit over the request made by the petitioner for months together and he ought to have taken a decision in the matter by now. In such circumstances, this Court is of the considered view that it would be appropriate to direct the first respondent to pass appropriate orders on the request made by the petitioner.

5. Accordingly, this Writ Petition is disposed of, directing the first respondent to pass appropriate orders on the proposal dated 30.04.2025 submitted by the petitioner, seeking permission to fill up the post of B.T. Assistant (English) in the petitioner school, as expeditiously as possible, at any rate, within a period of four weeks from the date of receipt of a copy of this order. No costs.

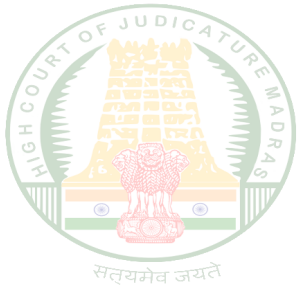
