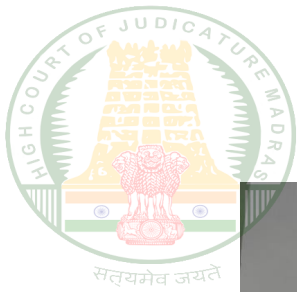
ORDER

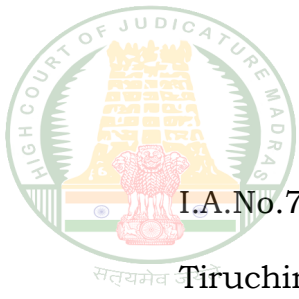
Memo filed by the 1st Respondent

The learned District Munsif is requested to correct the cause-title accordingly by deleting the Advocate and the Advocate Clerk from the array of parties.

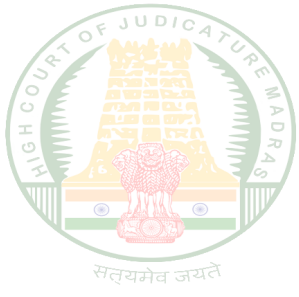
3.This Civil Revision Petition is ordered in the above terms. No costs. Consequently, connected Miscellaneous Petition is closed.
