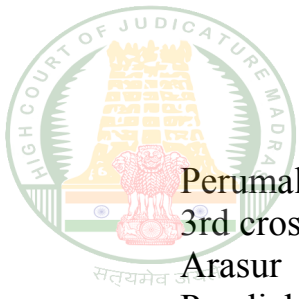

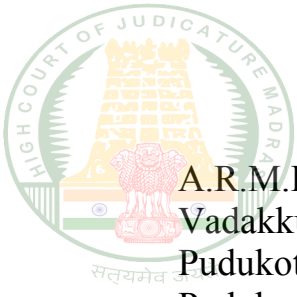

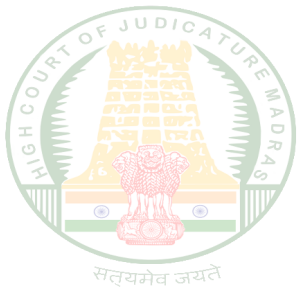
Prayer:

Second Appeal filed under Section 100 of Civil Procedure Code, to set aside the judgment and decree dated 10.12.2025 in A.S. No. 8 of 2023 passed by Sub Court, Keeranur reversing the judgment and decree dated 09.08.2018 passed by District Munsiff Court, Keeranur in O.S. No. 9 of 2010 and thus render justice.

ORDER

This Second Appeal is admitted on the following substantial questions of law:

“1) Whether the First Appellate Court was right in deciding the issue of reconstitution and sub-division of

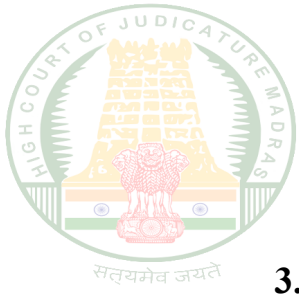
S.No.55/2, Sathyamangalam Village, Kulathur Taluk, Pudukkottai District without any pleading in the plaint in this regard?

2) Whether the First Appellate Court was right in ignoring Ex.A.1 and A.2, the documents of title of plaintiff which conveys only 28 cents of lands in S.No.55/2, Sathyamangalam Village, Kulathur Taluk, Pudukkottai District and decree the suit for larger extent as project in item 3 of plaint schedule?

3) Whether the First Appellate Court committed a serious error in ignoring and misinterpreting the categorical admission of P.W.1 with regard to the title, sub division and extent of land as contained in Ex.A.1 and A.2 thereby resulting in miscarriage of justice?

4) Whether the First Appellate Court committed a fundamental error in analysis of the pleadings of the parties and rendering a finding that defendant did not deny the reconstitution of lands and allocation of extent of 2.85 acres in S.No.55/2, Sathyamangalam Village, Kulathur Taluk, Pudukkottai District, as projected by the plaintiff, when the same has been specifically denied more particularly with regard to extent in the Written statement?"

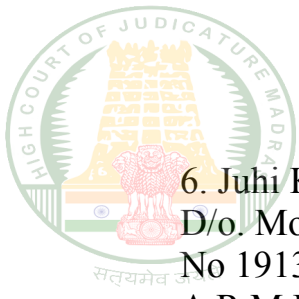
