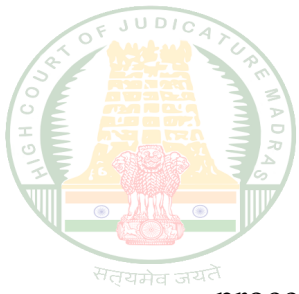

ORDER

The writ petition is filed for a mandamus directing the 2nd respondent to implement the order of the 1st respondent vide proceedings dated 02.03.2021 on the basis of the petitioner's representation dated 27.03.2026.

2. The learned counsel appearing for the petitioner would submit that the land was originally recorded in the name of the Administrator of Rajah's High Secondary School. However, during the UDR exercise, the same was wrongly classified in the individual names of certain school committee members. Proceedings dated 02.03.2021 had already been passed to correct the same and the said order is stated to have been implemented. Hence, the petitioner is before this Court.

3. When the matter came up for hearing today, learned Government Advocate, taking notice on behalf of the respondents would submit that detailed orders had already been passed by the 3rd respondent on 21.03.2025, whereby the 'A Register' was directed to be corrected. It was further submitted that the District Revenue Officer had already passed an order dated 21.03.2025 carrying out the same. A copy of the said order was also furnished to the Court. Upon perusal of the same, it can be seen that the 'A Register' has been ordered to be restored in the name of Rajah's High Secondary School.

4. In view thereof, the prayer sought for in the writ petition stands satisfied. Recording the same, the writ petition stands closed. The necessary corrections pursuant to this order shall be carried out in all computerized records within a period of three months from the date of receipt of a web copy of this order. No costs.
