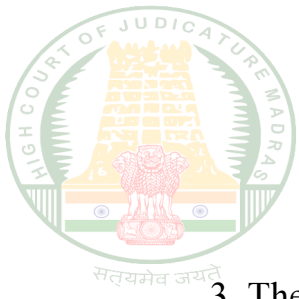

PRAYER :- Writ Petition, filed under Article 226 of the Constitution of India, praying this court to issue a Writ of Mandamus, directing the 3rd respondent to take necessary steps to issue fresh patta to the petitioners in their individual names to their corresponding shares for the above said property in SF.No.338/4b2 situated in at Thiruchuli village, Aruppukottai, Virudhunagar District, in the light of the decreetal order passed in the suit for partition in O.S No.259/2002 by the Additional District Munsif Court, Aruppukottai, dated 28.11.2016 and the Execution order passed in E.P.No.14/2012 dated 26.7.2022 by considering representation dated 20.12.2024.

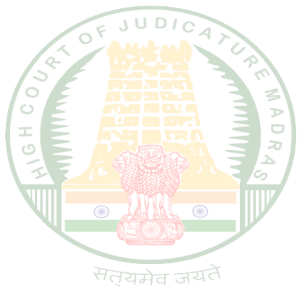

WMP(MD)No.9627 of 2026 filed to permit the petitioners to file a single writ petition is ordered.

2. The present writ petition has been filed for a Mandamus, directing the 3rd respondent to take necessary steps to issue fresh patta in the petitioners' individual names.

3. Originally, the survey field No.338/4b2 belongs to the petitioners' father Saravanakumar. During his life time, he has executed a registered will in Document No.14/1946 dated 26.09.1946. Thereafter, he died leaving behind the legal heirs namely, 1)Amirthavalli, 2)Gandhiyammal, 3)Sahayavalli, 4)Saraswathi, 5)Janaki, 6)Pothumani and 7)Pakyam. The patta was also standing in the name of Saravanakumar in No.8194. After his demise, his daughters were enjoying the property jointly. Since the property ought to be divided among the siblings, the petitioners filed the partition suit in O.S.No. 259/2002 before the Additional District Munsif Court, Aruppukottai and the same was allowed. Thereafter, execution petition in E.P.No.14/2012 was also filed. The Commissioner was appointed and the property was partitioned vide order dated 26.07.2022. Now as per the final decree, 6/7 shares are allotted to the petitioners. Hence each petitioner is entitled to 1/7 share. Now the petitioners are seeking to divide the property as per

the E.P and issue separate patta to the individual names of the petitioners
by considering their representation dated 20.12.2024.

4. The Revenue Divisional Officer/2nd respondent is directed to consider the petitioners' representation dated 20.12.2024 in the light of the decree passed in the partition suit in O.S.No.259/2002 on the file of the Additional District Munsif Court, Aruppukottai, and E.P.No.14/2012 dated 26.07.2022 and pass appropriate orders within a period of five months from the date of receipt of a copy of this order.

5. With this direction, the Writ Petition is disposed of. No costs.

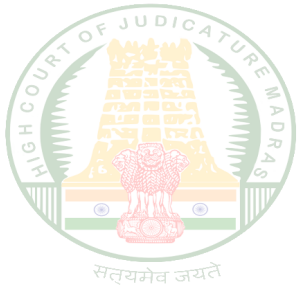
