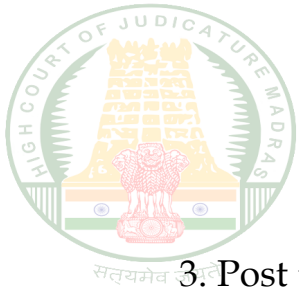
Prayer in CMP(MD). 8109/ 2024 :

2. There shall be an order of Interim stay on condition that the appellant deposits 50% of the award amount with proportionate interest and costs to the credit of M.C.O.P.No.113 of 2019, on the file of the Motor Accidents Claims Tribunal, Special Court for Forest, Nagercoil, within a period of eight weeks from the date of receipt of a copy of this order, failing which, interim stay granted shall stand automatically vacated without further reference to this Court.
