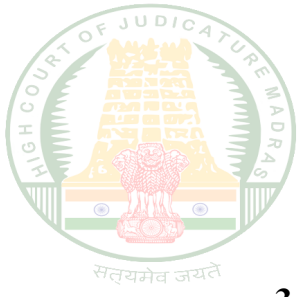
Prayer:
