2.The learned Standing Counsel appearing for the respondents 2 & 3 submits that the petitioner, who appeared for the selection process of the year 2019, has filed this writ petition seeking mandamus in the year 2023. On this ground alone, this writ petition deserves to be dismissed. He also submits that the cut off marks secured by the petitioner in the said selection process is 67, whereas, the cut off mark in SC-A category is 71 and therefore, the petitioner is not eligible and his candidature has not been considered.
