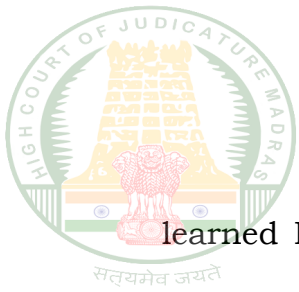

3. With the above direction, this Civil Revision Petition is disposed of.

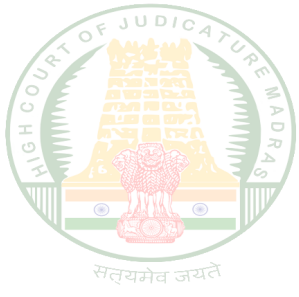
