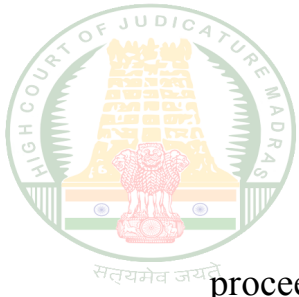

This writ petition has been filed seeking writ of Certiorarified Mandamus calling for the records relating to the impugned



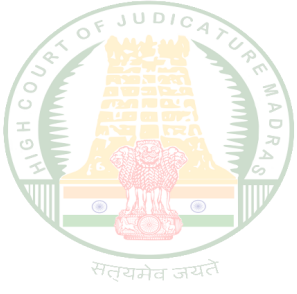

proceedings issued by the 4th respondent District Educational Officer in Na.Ka.No.4648/A5/2024 dated 23.09.2025 quash the same and further direct the 3rd and 4th respondents to approve forthwith the appointment of the Tmt.G.Mary Latha as B.T. Assistant (Science) in the petitioner's school w.e.f. 18.11.2015 and disburse grant-in-aid towards her salary and other attendant benefits.

2. Today, when the matter is taken up for consideration, it is brought to the notice of this Court by Mrs.K.Porkodi, learned Government Pleader appearing for the respondents that notwithstanding the impugned proceedings, the appointment of Tmt.Mary Latha, B.T. Assistant (Science) in the petitioner-school was already approved by the competent authority, vide proceedings dated 11.06.2026.

3. In the circumstances, this Court is of the considered view that the relief sought in the writ petition has become infructuous.

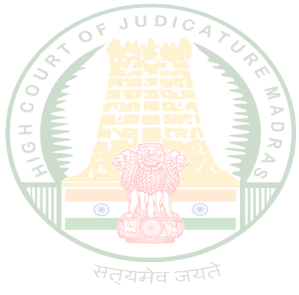
