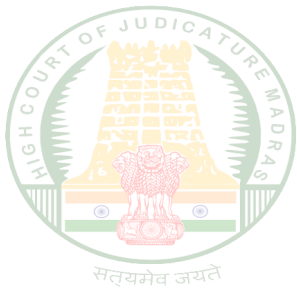

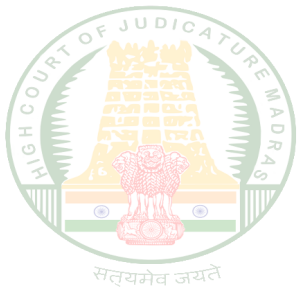
ORDER

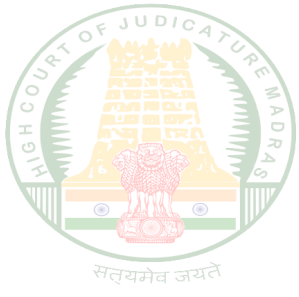
5. In the said circumstances, this writ petition is allowed

The respondent is further directed to comply with the said direction as expeditiously as possible, at any rate, within a period of FIVE MONTHS from the date of receipt of a copy of this order. No costs.
