This is a case, where the terminal benefits of the petitioner have not been disbursed on the ground of an audit objection. The audit objection appears to be on the ground that the petitioner has not undergone foundational training course. The petitioner has no option to undergo the said training unless he is deployed for the said purpose by the employer. Therefore, withholding of the terminal benefits of the petitioner on the said ground *prima facie* appears to be arbitrary and unconscionable.
