ORDER

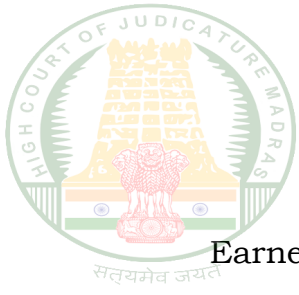
Mr.K.Ramaiah, learned Standing Counsel, takes notice for the respondent.
