that the petitioner is entitled for an amount of Rs.5,76,000/- and the same would be disbursed within a period of one week from today.

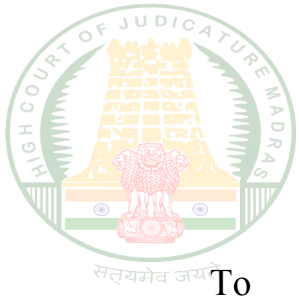
