ORDER

WEB COPY The writ petition has been filed challenging the impugned refusal check slip dated 07.04.2026.

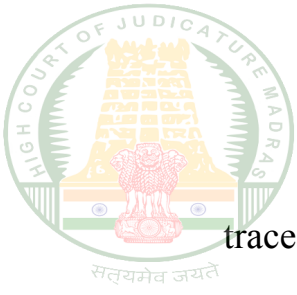
2. When the petitioner presented the document for registration, the same was refused on the ground that the original parent document was not produced.

3. The learned counsel for the petitioner submitted that the original document is missing and that the petitioner will re-present the document after obtaining a non-traceable certificate. It is further submitted that the petitioner is aged about 96 years and that there is urgency in the matter.

4. This Court also heard the learned Additional Government Pleader appearing on behalf of the respondents.

5. This writ petition is disposed of on the following terms:

(i) The petitioner shall approach the jurisdictional Police with regard to the missing document. Upon such approach, the Police, by taking into consideration the relevant circulars issued in this regard, shall verify the claim and, if satisfied that the document is not

traceable, issue a non-traceable certificate at the earliest.

(ii) Upon obtaining such certificate, the petitioner is at liberty to re-present the document for registration. On such re-presentation, the document shall be registered, notwithstanding the earlier refusal check slip, if it is otherwise in order and if there is no other legal impediment.

(iii) Considering the age of the petitioner, the above exercise shall be completed as expeditiously as possible.
