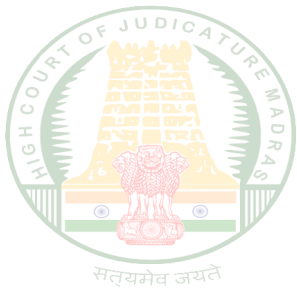

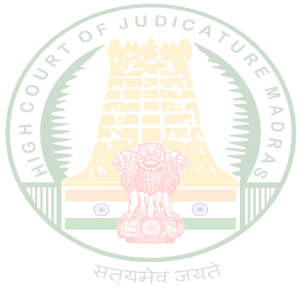

ORDER

The impugned proceeding herein is admittedly an order issued pursuant to a Judgment passed by the learned Division Bench of this Court in W.A.(MD) No.1755 of 2024 etc. batch, dated 26.09.2025. 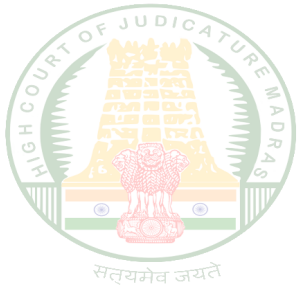
