3. In view thereof, this writ petition is disposed of on the following terms:-

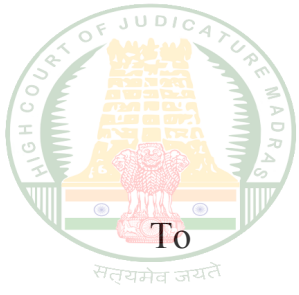
