2. The learned counsel for the respondents seek time to file a response to the report of the Advocate Commissioner.

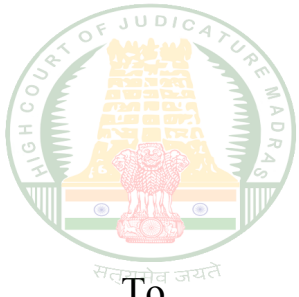
3. Considering this, the interim order already granted by this Court is extended until further orders.
