Prayer:

To grant an order of leave for filing of the Civil Revision Petition against the order passed in E.P.No. 79 of 2005 in O.S.No. 319 of 2004 on the file of the 1st Additional District Court, Trichy dated 20.02.2026.

ORDER

Pursuant to the orders of this Court on 30.04.2026, Mr.V.R.Shanmuganathan has entered appearance for the decree holder. He has filed a typed set of papers. He argues that before delivery was taken, as per the orders passed in E.A.No.1 of 2026 in E.P.No.79 of 2025 dated 15.02.2007, a valuation was done and a report was obtained on 22.05.2026. As per the valuation, the amount that was arrived at is Rs.5,29,000/-. A schedule of lodgment was filed and since orders are yet to be passed by the Executing court, the amount has not been deposited.

2. The learned I Additional District Judge at Tiruchirappalli shall send the entire papers in E.P.No.79 of 2005 together with all the miscellaneous papers for perusal of this Court by 11.06.2026. The records to be sent by special messenger.

3. Mr.V.R.Shanmuganathan to produce the bond executed by the decree holder in favour of the Court together with the list of articles of which the decree holder has taken possession of.

4. Post the matter on **11.06.2026**. Status quo with respect to the property shall be maintained. The learned I Additional District Judge shall



ensure that status quo as on today is maintained by calling upon the bailiff to secure the property under his control.

5. Registry is directed to inform the learned I Additional District Judge, Tiruchirappalli forthwith about this order.

6. The goods, which have been taken possession of by the decree holder from the EP scheduled premises shall be handed over to the Court by the end of day on 08.06.2026. Report of compliance should be filed on the next hearing date.
