ORDER

Heard the learned counsel for the petitioner.

2. Mr.T.A.Om Prakash, learned counsel, appeared on behalf of respondent Nos.1 to 4 & 6.

3. Issue notice to the 5th respondent, returnable by six weeks.
Private notice is also permitted.

4. Considering the facts and circumstances of the case, this Court is inclined to grant an interim stay till the disposal of the Civil Miscellaneous Appeal in C.M.A.(MD)No.219 of 2026, subject to a

condition. Accordingly, an order of interim stay is granted on condition that the petitioner shall deposit the entire award amount, along with accrued interest and costs, to the credit of M.C.O.P.No.688 of 2014 on the file of the Motor Accident Claims Tribunal / Special District Court No.II, Tiruchirappalli, within a period of six weeks from the date of receipt of a copy of this order, failing which the interim stay granted shall stand automatically vacated without any further reference to this Court.

5. Upon such deposit being made by the petitioner, respondent Nos.1 to 4 & 6 are permitted to withdraw 50% of the deposited amount in M.C.O.P.No.688 of 2014, as apportioned by the Tribunal, by filing necessary application before the Motor Accident Claims Tribunal / Special District Court No.II, Tiruchirappalli.
