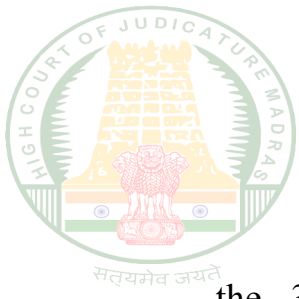

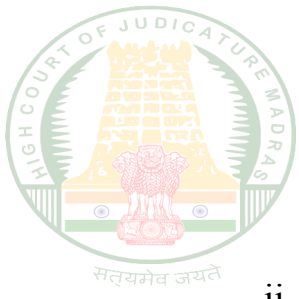
3. It is the case of the petitioners that when they had duly taken the token and presented the document for registration, it was not even accepted by the Sub-Registrar and was orally refused. The petitioners have also subsequently made a representation.

4. When the matter came up for hearing today, the learned Additional Government Pleader, on written instructions, submitted that the signature of the draftsman of the Sale Deed was missing. However, if the document is represented in proper form, it will be considered.

5. In reply, the learned counsel for the petitioners submitted that the document is in proper form.

6. In view of the submissions made, the writ petition is ordered as follows:-

- i. Within a period of one week from the date of receipt of the web copy of the order, the petitioners shall represent the documents through their power agent with the office of the 3rd respondent;

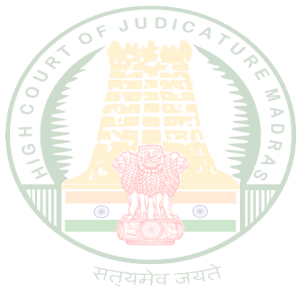
