3.Apart from the other grounds raised by the petitioner, while the Employees' Provident Funds and Miscellaneous Provisions Act, 1952 stands repealed by the Code of Social Security, 2020, even though the original scheme framed under the Act, is kept intact until the new scheme is framed, whether the assessment proceedings can be made under Section 7A of the Act or 124 of the Code and what will be the remedies available to the petitioner is the question.
